#### Your team

You will be part of the Production Section in the Directorate Banknotes. The Section coordinates and monitors euro banknote production; develops and manages the procedure for accrediting manufacturers of euro banknote components; develops and manages the common quality, health and safety and environmental management systems for banknote production; and conducts quality inspections of production sites of raw materials suppliers and printing works.

We are now seeking a trainee specialised in the environmental impact and sustainability of production.

To further enhance the diversity of our team, we particularly encourage applications from female candidates.

#### Your role

As a trainee you will:

- contribute to developing the use of sustainable cotton fibres in euro banknote paper (e.g. researching different labelling schemes, assessing supply chains to find out what sustainable cotton fibres the euro paper mills use and researching the use of recycled cotton fibres);
- research possible ways to reduce the environmental impact of disposing of used banknotes and devise strategies to encourage environmentally friendly disposal;
- contribute to the definition and implementation of a single indicator for measuring the environmental impact of euro banknote production;

- process environmental data provided by the accredited manufacturers;
- contribute to setting up a euro banknotes production database.

You will be part of a multicultural team that strives for continuous innovation to make a positive impact on the lives of European citizens.

### Qualifications, experience and skills

#### Essential:

- knowledge of methods for calculating environmental impact, e.g. life cycle assessment (LCA);
